

These Terms and Conditions illustrate the rules on how to use the BEER CARD and the BEER WALL at The Alchemist Gastropub. Below are some definitions:

Card – is the Beer Card with a unique number, that you can purchase at The Alchemist at Plac Piłsudskiego 3, 00-078 Warszawa. The card is sold by E.S.Bacchus Sp. z o.o. company. The card is used to purchase alcoholic beverages at the Beer Wall in The Alchemist Gastropub.

Card Holder – is the person who purchased or was given the Beer Card

Unit – is the gastronomy place The Alchemist by Plac Piłsudskiego 3, 00-078 Warszawa

## § 1. General Rules

1. Beer Card is the pre-paid card that is used to make all purchases done at the Beer Wall in the unit. Beer Card can only be used for the transactions by the Beer Wall and cannot be used to pay for any other transactions done at the Unit. The Beer Card cannot be exchanged for cash.
2. Before using the card make sure that you have sufficient funds on it
3. The funds will expire 6 months after the last use. 'The card use' means using it to purchase a drink from the Beer Wall
4. The card is not your credit card and is in no way connected to your bank account and you cannot use it to pay for items or services in different places
5. The Alchemist or E.S.Bacchus sp z o.o. are not refunding any other funds left on the card that you no longer wish to use.
6. Beers and other drinks on the Beer Wall change regularly. Check at the bar for the latest selection and prices. The alcoholic drinks are prices also subject to change.
7. If the card holder does not have the card on him/her, they cannot purchase the drinks at the beer Wall as The Alchemist does not issue replacement cards if left somewhere else or lost or stolen

## § 2. Purchasing, activating and using Beer Cards

1. The Beer Card can be purchased at the bar at The Alchemist. To purchase the card you must be of at least 18 years of age. Also to use the card you must be at least 18 years old. The seller reserves the right to ask you for your ID in order to verify your age. Purchase of the card by a person under 18 is against the law.
2. The fee for the empty card without funds is 5zł. Then you need to top up the funds on the card by purchasing the credits at the bar. You can buy the credit with both cash and/or a bank card. Topping up the card in places other than The Alchemist is against the law and those credits will not be recognised.
3. Copying and cloning the card is against the law and such a card can be confiscated.
4. By purchasing the Beer Card, you are automatically agreeing to these Terms and Conditions.
5. After topping up the card, the funds are ready to be used immediately.
6. Beer Card is not a bearer card and is not assigned to one person, which means that it can be used by a number of people, only if they are at least 18 years of age. Sharing the Beer Cards with others who are under 18 is against the law and it is strictly prohibited. Beer Card is a multiple use card

7. When using the card in The Alchemist gastropub, our staff reserve the right to ask for ID of any users they suspect that they might not be 18 years old.
8. If the user does not have a valid ID at the moment of age verification, the card will be temporarily confiscated until the valid ID is presented and the user confirms the legal age in Poland for alcohol consumption (18 years). If the card holder is younger than 18, then the card will not be returned and the funds will be voided.
9. The Alchemist does not charge any additional monthly fees for using the card
10. Payment process – the funds are deducted from the card with the moment it is used to purchase the drink by the Beer Wall.
11. During the transaction by the Beer Wall (which means pulling the drink tap whilst the card is inside the card reader), the user is charged for the drink every 20ml. After the drink has been poured and paid for, the purchase history is registered on the card
12. Every consecutive use of the card to purchase the drinks at the Beer Wall automatically extends the validity of the card for the next 6 months.
13. Purchasing the card as a present for the person under 18 against the law and such card will be automatically confiscated. When purchasing a card as a present, the new card holder will need to activate the card at the bar and might be asked to confirm with a valid ID that is over 18.

### § 3. Blocking the Beer Card

1. The funds on the card can be used up to 6 months from the last use. If the card holder hasn't used the card for a period longer than 6 months since the last use, The Alchemist reserves the right to void the funds on such a card and such card is considered pass expiry date and invalid.
2. If the use of the card is extended in time, and there are long patches of time in between uses, the card holder might have to reactivate the card in the bar. The funds topped up will remain on the card. When re-activating the card, the card holder may be asked for a valid ID as a proof that the card holder is over 18. If the card ends up in the possession of a card holder who is under 18, The Alchemist reserves the right to confiscate such a card immediately and permanently deactivate the card
3. The Alchemist also reserves the right to temporarily block the card if the card holder consumed too much alcohol in one night; this is in care of the health of the card holder.
4. The Alchemist is not liable for damaged or lost cards or damages resulting from wrongful use of the cards

### § 4. Duties and Responsibilities of the Card Holder

The Card Holder is obliged to:

1. Obey the rules of Terms and Conditions of using the Beer Card
2. Use the card responsibly and with care, having in mind your own security and security of others
3. Use the card only while it's valid
4. Not make the card available to anyone under 18

### § 5. Card Balance and Purchase History

1. The card holder can check the balance of the card at the bar in The Alchemist or by inserting the card into the card reader at the Beer Wall

2. The card holder can check the purchase history by inserting the card into the card reader by the Beer Wall and pressing the Balance on the screen

These Terms and Conditions are governed by Polish Law.

The Alchemist reserves the right to change the Terms and Conditions at any time, in such a case new Terms and Conditions will be published immediately.

No personal data, apart from a legal proof that the card holder is over 18, is required to purchase the card

## § 6. Final regulations

1. These terms and conditions are governed by the Polish law
2. The terms and conditions are available on the website [www.thealchemist.pl](http://www.thealchemist.pl). Terms and conditions can change and the new terms and conditions will be then updated and available on the website [www.thealchemist.pl](http://www.thealchemist.pl)
3. To purchase the Beed Card, you do not need to provide any information or personal data other than ID card to prove your age over 18. Showing ID is purely to verify the age of the customer, according to the Polish law on sobriety and working against the alcoholism – article 15, the rule number 2 from the set of rules from 26<sup>th</sup> October 1982. When selling the Beer Card, E.S.Bacchus is not collecting, keeping or processing any personal data of the person purchasing the Beer Card. The Beer Card does not record any personal data.
